*renewal year - membership cards issued in 2010 & 2011 will be used this season. Upon renewal, present your cards to be validated with a "starfish" punch for the upcoming season. Lost/Misplaced cards issued at no additional charge.

FAMILY PASS ELIGIBILITY

"Family" is defined as all immediate family members residing at the same address - this would include full-time college students, stepchildren, adopted children and foster children. It does not include babysitters or visiting relatives (sons, daughters, cousins, grandchildren, grandparents, etc.) In order to participate in a family membership, such persons must be claimed as a dependent to the IRS by the person making the application for membership.

CAREGIVER PASS ELIGIBILITY

"Caregiver" is defined as an individual age 14 years or older who will be attending the aquatic facility with your child(ren). The caregiver need not be related. Only one caregiver per family membership is permitted and must be purchased in conjunction with a family membership.

ADDITIONAL INFORMATION

In addition to the Family Pass Eligibility requirements, "family" also consists of:

1. Foreign exchange students who are permanently residing at the address on the applications.
2. Grandchildren who are permanently residing at the home of a grandparent for the entire summer.

MEMBERSHIP ID CARDS

- ☞ ID cards must be presented at the time of entrance into the Park. Admission will not be granted without a valid 2012 ID.
- ☞ ID cards issued in for last season will need to be presented in order to be validated with a "starfish" punch for the upcoming season. Individuals who misplaced their ID card can request a replacement card on the season pass application.
- ☞ ID cards are to be used only by the person to whom they are issued. They are not transferable.
- ☞ The replacement fee for a lost or damaged pass is \$5.00. Please allow 2-3 business days for ID card replacement.
- ☞ Season pass refunds will NOT be issued after opening day, June 4, 2012.
